	Begins the process of applying for student loans for new graduate program students enrolled in the November 2023 to February 2023 quarter (2024-23 term).
November	Last student loan application period for students enrolled at the undergraduate level (Associate Degree, Baccalaureate, or Technical and Vocational Certificate Programs) in the semester of August to December 2023 (term 2024-10).
	Application of financial aid from the quarter of November to February (term 2024-23).
	All students enrolled in the August-November quarter (2024-13) who finish their degree in November 2023 are required to complete Direct Loan Program Exit Counseling in <u>https://studentaid.gov</u>
December	Last date to complete FAFSA 2023-2024 for new students enrolled in the January through May 2024 semester (term 2024-30). Link <u>https://studentaid.gov/h/apply-for-aid/fafsa</u>
	Students enrolled in the August to December semester (2024-10) and finish their degree in December 2023 have to complete Counseling Exit from the Direct Loan Program in <u>https://studentaid.gov</u>
	Start the process of completing the FAFSA for the 2024-2025 academic year. Link <u>https://studentaid.gov/h/apply-for-aid/fafsa</u> . The 2024-2025 FAFSA application will

January	Start the student loan application process Undergraduates and graduates who are enrolled in the February to May 2024 (term 2024-33).
	Delivery of required documents of the Verification Process for new students enrolled in the semester from January to May 2024 (term 2024-30), who have been selected for this process.
	Complete Application for Professional Judgment for new students enrolled in the semester of January through May 2024 (term 2024-30) who wish to request a reevaluation of financial aid through the Professional Judgment process. The deadline to submit the application is March 22, 2024.
February	First application of financial aid from January to May 2024 (term 2024-30).
	Students enrolled in the November to February 2024 (2024-23) quarter and finish their degree in February 2024 have to complete Direct Loan Program Exit Counseling in <u>https://studentaid.gov.</u>
March	Enrollment processes begin for the terms of July, August Intensive and August 2024, for new students and active students.
	The evaluation of financial aid for students enrolled in the first summer session of June (term 2024-50) begins.
	Application of financial aid from the quarter of February to May (term 2024- 33).

The process of evaluating financial aid begins for terms of July, Intensive August and August 2024 Last day to complete Direct Loan Program Exit Counseling in https://studentaid.gov forstudents completing their academic degree in May 2024. Application of financial aid of the summer section June (term 2024-50). June Loan application process begins for students of the graduate and undergraduate July programs and are enrolled in the various academic terms that begin in August 2024. Application of financial aid of the summer section July (term 2025-04). Continue with the Verification Process to the selected students for the year 2024-2025. 	Date to complete Application for Professional Judgment for new students enrolled in the semester of August to December 2024 (term 2025-10) who wish to request a reevaluation of financial aid through the Professional Judgment process. The deadline to submit the application is October 11, 2024.
September	Application of financial aid for the semester from August to December 2024 (term 2024-10).
